The Constitution of the Organisation for People's Rights (COPR) as amended on 04 June 2020

- 1 This and the next fifty-four sections will constitute the Constitution of the Organisation for People's Rights (COPR).
- 2 The Organisation for People's Rights (OPR) shall bear true faith and allegiance to the Constitution of India as by law established, and to the principles of socialism, secularism and democracy and would uphold the sovereignty, unity and integrity of India.
- 3 The OPR's Vision is to help the people and the government to establish true democracy in India, with fair uniform law without corruption, for everyone in the nation, so that every citizen will have basic rights to lead a decent life with one's own effort, without fear or having to bow to anyone.
- The OPR has adopted 'the Constitution for the People' (CP) with four hundred and thirty sections of reforms, created by Hari, to achieve OPR's Vision. The OPR envisions this later spreading to the whole world.
- The registered original document will be kept in the custody of the first Trustee and the second Trustee will keep a copy of it. The first Trustee may at any time hand over the original document to the Creator of the CP for safe custody. The first Trustee will then keep a copy for himself.
- 6 The first part of the OPR's Mission is to take the CP to the citizens of India to find out whether majority of the citizens of India want these four hundred and thirty sections of the CP incorporated in the Constitution of India.
- The second part of the OPR's Mission, if the majority of the citizens of India want to incorporate the four hundred and thirty sections of the CP in the Constitution of India, is, to help the people to follow the exact procedure in the current Constitution of India, to incorporate all four hundred and thirty sections of the CP in the Constitution of India. The OPR believes that these sections of the CP are truly democratic and fair and which, when incorporated in the Constitution of India will achieve OPR's Vision.
- 8 The Trustees, being the first two members of the OPR, after the registration of the OPR, will accept membership from Indian citizens, subject to relevant sections of this COPR.
- 9 The Trustees will conduct a members' meeting and elect from among the members including the trustees, a President of the National unit of the OPR, a Secretary of the National unit of the OPR and a Treasurer of the National unit of the OPR.
- 10 The first Trustee will provide a copy each of the registered original document, including the CP and the COPR, to the President of the National unit of the OPR, the Secretary of the National unit of the OPR, and the Treasurer of the National unit of the OPR.
- 11 The National Unit of the OPR may establish State, District and Community unit/s of the OPR, with three office bearers to manage each unit.
- 12 The State Unit of the OPR may establish District and/or Community unit/s of the OPR, with three office bearers to manage each unit.
- 13 The District Unit of the OPR may establish Community unit/s of the OPR, with three office bearers to manage each unit.
- 14 Three members or more in a new area where a unit of the OPR does not exist may found a new unit of the OPR, with support and guidance from higher unit/s of the OPR, using this COPR, without any change, as their constitution for their unit.
- 15 Every unit of the OPR may request the office bearers of higher unit/s for support and guidance for the development of the unit. Every unit is subject to supervision by the office bearers of the respective higher unit/s, in the order, Community Unit, District Unit,

- State Unit and National Unit.
- 16 Three members of the OPR who agree to work as the President, the Secretary and the Treasurer, during the founding meeting of any new unit of the OPR will become the three office bearers of each new unit of the OPR, if there are no more nominees.
- 17 All members present during the founding meeting of a new unit of the OPR, will conduct an election, if there are more than one candidate for the position of any or all of the office bearers.
- 18 The President of the National Unit of the OPR, upon request, will provide to office bearers copies of the CP and COPR, until the same is available on the OPR website.
- 19 Any or all of the units of the OPR, if the unit/s so decide, at any time in future may create the position/s of a Vice President, an Assistant Secretary and/or a Joint Treasurer.
- 20 The next President, the Secretary and the Treasurer, and if the positions exist, the Vice President, the Assistant Secretary and/or the Joint Treasurer will be elected by the OPR members in November of the next CP election year, which will be the year 2025. The subsequent office bearers will be elected by the OPR members in November of the next CP election year and so on (in the year 2030, 2035 etc.) subject to the relevant sections of the CP.
- 21 The primary goal of the OPR members and the office bearers is to take the CP to every citizen of India, to find out if he/she wishes to see all of the four hundred and thirty sections of the CP incorporated in the Constitution of India.
- 22 A citizen of India, who is aged eighteen years or above and who wishes to see the four hundred and thirty sections of the CP incorporated in the Constitution of India may join the OPR and become a new member of an OPR Community Group of the OPR.
- 23 A new member, immediately after joining the OPR, will take the CP to other citizens of India to find out if they too wish to see the 430 of the CP incorporated in the Constitution of India and if they say 'YES', the member will introduce those citizens too, as new members to the OPR community groups, and they will thus continue to introduce more new members to the OPR.
- 24 The OPR will not collect any donation for any purpose from the public or members of the OPR or an entity or the government.
- 25 The newly elected office bearers will start their term of five years in office on the first January of the year after the election year.
- 26 An office bearer who will have completed a full term of five years by the thirty first of December of the CP election year as explained in the CP will not stand for election as any of the office bearers of the OPR in the same level (Community, District, State or National) for the next term. This means, an office bearer will not serve two consecutive full terms in the same level unit, unless there is no other person to fill the position.
- 27 A current office bearer of an OPR unit may stand for election in any one of the other three level units.
- 28 An office bearer will serve only a maximum of two full terms in the same level unit of the OPR, unless there is no other person to fill the position.
- 29 An office bearer will serve only a maximum of five full terms in different levels units of the OPR, unless there is no other person to fill the position.
- 30 When the President, the Secretary and/or the Treasurer is/are on leave, the Vice President, the Assistant Secretary and/or the Joint Treasurer respectively will temporarily fill in his/her/their position/s.
- 31 A voter, during an election, can choose not to vote, or vote for one or more, or vote for all of the candidates.
- 32 The candidate who gets the highest number of votes will be elected as the office bearer.

- 33 When more than one gets equal highest number of votes, one will be chosen by taking lots.
- 34 All candidates who obtained more than fifty percent votes in the election will be in the rank list to take the respective position any time before the thirty first of December of the next CP election year, in case the elected office bearer ceases to be an office bearer for any reason.
- 35 The office bearers and all members of the OPR will abide by all sections of this Constitution of the Organisation for People's Rights (COPR).
- 36 The office bearers of the OPR, subject to this Constitution and all applicable current government laws, will have all powers to transact the general business of the OPR for the good and efficient management of the OPR.
- 37 The office bearers of the OPR will fulfil all obligations applicable to them as office bearers, under this Constitution and all applicable laws, and be responsible at all times, for their actions as office bearers.
- 38 The office bearers of the OPR will not use any funds of the OPR for any purpose other than for the purpose of the administration and good management of the OPR in performing its Mission and achieving its Vision.
- 39 An office bearer will not amass wealth for himself/herself, directly or indirectly, using the power of his/her position.
- 40 More than half of all members of a Community Unit of the OPR from where an office bearer/s is/are from (irrespective of the fact that he/she/they is/are office bearer/s of any level Unit of the OPR) will have the power at all times, to remove the office bearer/s from the position as office bearer/s. The next person/s in the rank list, made after the election, as per the provisions of the CP Election Rules will replace him/her/them. If the removed office bearer/s is/are, office bearer/s of their own Community Unit, then they may even disregard the rank list made after the election and may choose another member/s of their Community Unit, by submitting a written declaration signed by each one of them, to the President, if the President is not being removed or to the new President supported by the majority of the members.
- 41 The office bearers of the OPR at all levels will be working on a voluntary basis without any pay.
- 42 A unit of the OPR will not create any liability nor borrow money.
- 43 The OPR, before the establishment of the CP in the Nation, will conduct an election when more OPR members than the required number of nominees are willing to stand as independent candidates for public election as members of the government. The OPR will then choose only the ones who get the highest number of votes as the official nominees of the OPR to stand as candidates for public election as members of the government.
- 44 The OPR will support only one each independent candidate, chosen from among its members as per the previous section, for each of the available vacancies in all levels of the government, until the CP is established in the nation.
- 45 The members of the OPR, after the establishment of the CP in the Nation (People's Nation), may freely stand as candidates for election as a Delegate/member of the government, subject to other relevant sections.
- 46 A candidate for election as an office bearer of the OPR will not nominate him/her as a candidate for election as a member of the government.
- 47 A candidate for election as a member of the government will not nominate him/her as a candidate for election as an office bearer of the OPR.
- 48 The first government formed by the support of the OPR, after coming to power with sufficient majority, will incorporate in the nation's Constitution, within one year after

- coming to power, all sections of 'the Constitution for the People' (CP).
- 49 The government formed by the support of elected independent members of the OPR, in case the attempt to incorporate all of the sections of the CP in the Constitution of India is not successful within one year after coming to power, due to whatever reason, then will do the remedial work to fix the issues and then if necessary go for re-election when that is the only alternative option, to obtain increased/sufficient majority and then incorporate all of the sections of the CP in the Constitution of India.
- 50 The OPR will continue the work until it has sufficient majority to support the government to incorporate all sections of the CP in the Constitution of the nation.
- 51 To propagate the ideas of the OPR, each member may send the information provided by the OPR with all sections of the COPR and the CP through all available methods, including the Internet and social media to all people he/she knows all over the world.
- 52 Any and all of the funds held by the OPR in cash or in kind, including in any bank accounts and any other assets, after discharging all liabilities, will be transferred to the Community Government, in the event of the dissolution of the OPR. The members or the office bearers of the OPR will not receive any part of such funds in the event of the dissolution.
- 53 Ten percent of the total members of an OPR community unit may make a motion in writing and ask to amend and/or delete any or all of the sections of the COPR, or to add new section/s to this COPR. If the Community Unit members pass the motion with more than fifty percent Yes votes, the Community Unit will submit it to the National Unit.
- 54 The motion passed by a Community Unit of the OPR to amend and/or to delete any or all of the sections of the COPR, or to add section/s must be approved first by the Creator of the CP and the COPR, and then by more than two third majority (two out of three) of all OPR members, registered as members of the OPR as on the last day of the previous month.
- 55 The President, from all members, will call for 'Yes' votes to support and 'No' votes to oppose the motion. The motion will be declared as officially passed by the President of the National Unit of the OPR, if more than two third votes from Members are 'Yes' votes and only less than one third are 'No' Votes.
